A certification does not constitute a warranty or guarantee by the inspector or the Control Officer that the device meets any other standards of operation, safety, or efficiency.

If the report indicates that a wood-burning device is uncertified, the wood-burning device must be:

- **Removed from the property, destroyed and recycled if recycling is available; or**
 - Required Documentation - Provide receipt of destruction and/or recycling
- **Rendered permanently inoperable (provide evidence from the WBDInspector)**

Re-inspection by an inspector for verification of removal is required prior to close of escrow.
