NOTICE OF PROPOSED ACTION

PUBLIC NOTICE

Pursuant to Nevada Revised Statutes (NRS) Chapter 445B, District Board of Health Regulations Governing Air Quality Management (DBOH Regulations), and the Clean Air Act, Northern Nevada Public Health Air Quality Management Division (AQMD) issuing the following Notice of Proposed Action.

The AQMD received a complete application on 12/03/2024 for the modification of a Synthetic Minor Air Quality Permit to Operate AAIR16-0082 from the following applicant:

Apple Inc. 21505 Reno Technology Way Sparks, Nevada 89442

Apple Inc. (Apple) is located at 21505 Reno Technology Way in Sparks, NV. The Apple Inc. data center is comprised of multiple buildings owned and operated by Apple.

The facility operates 40 emergency engines to provide power to the facility in emergency situations. Apple submitted an application to modify their Synthetic Minor Air Quality Permit to Operate by installing selective catalytic reduction, diesel oxidation catalyst, and diesel particulate filter controls on twelve existing emergency engines. Apple did not request any changes to its allowable emissions during this permitting action. As there is no emissions increase as a result of this permitting action, a Best Systems of Control analysis is not applicable and was not conducted.

A summary of the facility's emissions is shown below:

Based on the preliminary review of the information provided by the applicant and the requirements of the NRS, the DBOH Regulations and the Clean Air Act, the AQMD is hereby announcing their intent to issue the proposed Permit to Construct. A copy of this Notice of Public Action (NPA), the application, the draft

Permit to Construct (PTC), and the Technical Support Document (TSD) will be available for public inspection at <u>ourcleanair.com</u>.

Persons wishing to comment regarding this proposed action should submit their comments or request in writing, either in person or by mail, within thirty (30) days to:

The application, TSD, proposed PTC, any comments received, and other relevant information may be copied at the above address or copies may be obtained by written request to the above address. Written comments or objections will be received at AQMD, above address, until July 13, 2025, and will be retained and considered prior to final action on the proposed Permit to Construct.

The AQMD will submit the proposed PTC to the U.S. Environmental Protection Agency (EPA) for a 30day review period on the same day the 30-day public comment period commences. If the AQMD has not addressed any received comments in a satisfactory manner, and the EPA does not object to the Authority to Construct during its review period, the public may submit a petition to the EPA requesting to reconsider issuance within 60 days after the expiration of the 30-day review period.

Any person may petition the AQMD in writing to hold a public hearing. If a proper petition is filed and the AQMD determines that there is a significant degree of public interest, the AQMD shall hold a public hearing no sooner than 30 calendar days, but no later than 70 calendar days, after the date of this Notice of Public Action. In determining if a significant degree of public interest exists, the AQMD shall consider all relevant factors, including, but not limited to, the number of petitioners, the nature of their concerns as stated in their petitions, and the type and quantity of emissions emitted by the source and the proximity of the source to sensitive areas such as parks, schools, hospitals, or residential areas. At least seven calendar days prior to the public hearing, notice of the public hearing shall be given to the petitioner, to the applicant, and to those listed in DBOH Regulations 030.200.E.3.a.(5) in the same manner as required for the NPA.
